



Warranty

**Warrior Limited Warranty
Construction Track.
Effective January 1, 2023**

Eligibility

Original owner of new Warrior service track and purchased through an authorized Warrior dealer. The warranty term begins on the sales receipt date to the customer.

Coverage

This warranty Agreement covers only Warrior Replacement Rubber Tracks and its Authorized Dealers. Warrior construction track is warranted against defects in materials and workmanship. Tracks that become unserviceable as a result of a disabling defect in materials or workmanship during the warranty period will be eligible for coverage. Track eligible for coverage will be (at Warrior choice) repaired, replaced, or a prorated allowance given towards purchase of replacement Warrior Tracks.

Owner Responsibility

- Transportation to location used to perform warranty work.
- Track removal and installation costs.
- Freight and duty charges and other expenses if required.
- Machine undercarriage components

Pair Track Replacement

The cost of replacement of opposite side tracks is not covered. Tracks with significant wear that are replaced during normal use or under warranty, it is the customers responsibility to determine if the opposite side replacement is required which shall be done at the customers' expense.

Exclusions from Coverage

- Track no longer owned by the original purchasing end user.
- Claims outside the listed months of service coverage.
- Track manufactured more than 60 months prior to warranty request.
- Damage from use or installation as a result of misapplication, or exceeding the specifications of the track original design capabilities.
- Damage from misuse, alteration, negligence, accident, or as a result of poor mechanical condition of the machine, or failure of operator to reasonably follow operational inspection and adjustment guidelines.
- Minor cosmetic defects, such as surface cracks, splits, and other

Warranty Period

If a track is replaced due to a defect in materials and workmanship during the original track warranty period, the replacement track warranty term will be limited to the remainder of the original track warranty term.

Prorated Replacement Tracks

Tracks found to be damaged due to a disabling defect in materials and workmanship will be credited on a prorated basis. The customers responsibility will be based on the participation chart above once full coverage has ended.
